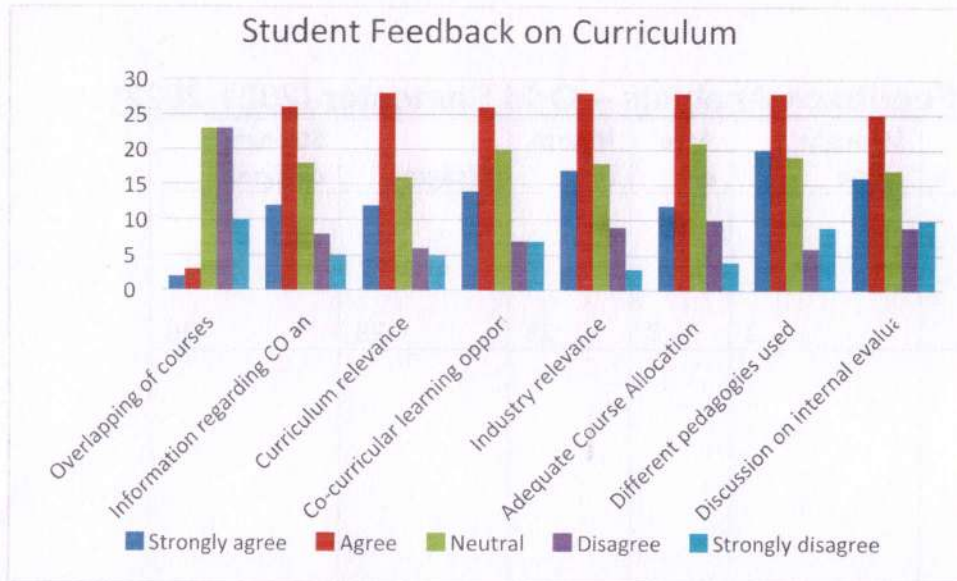



Analysis of the feedback from students indicates that 87.5 percent of the students feel that there is no overlapping of courses, 92 percent of the students do not recommend introduction of new courses and also that all the courses are adequately placed in the programme structure. Further, 83 percent of the students had no suggestions for faculty improvement.
